

## 50/50 Raffle – Official Rules (Vancouver Giants)

- 1. <u>General:</u> The Langley Facilities Society ("LFS") operates Electronic 50/50 Raffle ("Raffle") to allow attendees at events at the Langley Events Centre to participate in a fundraising initiative that supports charitable groups. The Raffle is operated through an electronic system that uses sophisticated hardware and software for the purchase of tickets and for generating, tracking, storing and reporting on numbers associated with purchased tickets (the "System"). The System has been certified by the BC Gaming Policy and Enforcement Branch. By participating in the Raffle, entrants agree to be bound by these Official Rules and by the decisions of LFS which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, provincial, and local laws and is void where prohibited.
- Jackpot: The "Jackpot" shall be the total proceeds from Raffle tickets sold for that drawing ("Raffle Tickets"). The amount of the Jackpot will be tracked by the System, and the continuously updated amount will be publicly posted at the Langley Events Centre and, if applicable, announced periodically inside of the facility during the Raffle.
- 3. <u>Allocation of Proceeds:</u> Each Raffle winner will receive a prize equal to fifty percent (50%) of the Jackpot for the particular event. The other fifty percent (50%) of the Jackpot will benefit the designated charity for the event less any applicable administrative costs. In the event of a bonus, the winner will receive the fifty percent of the event jackpot plus the full amount of the bonus that was added to the draw.
- 4. <u>Eligibility:</u> The Raffle is open only to all persons who are located in the Province of British Columbia at the time of entry and who are nineteen (19) years of age or older and otherwise meet the conditions specified in these Official Rules. Notwithstanding the foregoing, the following individuals shall be ineligible to win: contractors, staff and volunteers who are directly associated with selling and administering the Raffle, LFS directors, and members of the particular events' designated charities' board of directors.
- 5. <u>Purchasing Raffle Tickets:</u> Ticket Prices: Three (3) for \$5, Seven (7) for \$10, Eighteen (18) for \$20 and Fifty (50) for \$50. There is no limit to the number of Raffle Tickets an individual may purchase. Tickets may be purchased in person at designated kiosks or from roving Raffle Ticket sellers. Ticket buyers receive a printed receipt listing all of the numbers purchased. Raffle Tickets may be available for purchase 90 minutes before the start of the Vancouver Giants game and the draw will occur as close as possible to the first break in game play at the beginning of the 3rd period ("Purchase Period").
  - If the System experiences any technical difficulties, or if the purchase period is suspended or cut short due to natural or unnatural causes of the hockey game or of the facility, LFS reserves the right in its sole discretion to cancel or suspend the Raffle until the problem can be remedied. If a problem cannot be remedied before the end of the game or if the game does not play past the draw time, monies collected will be used as a bonus to the prize of another draw within the next 12 months where similar ticket buyers are likely to be present
- 6. <u>Selection of Winner:</u> Upon the conclusion of the Purchase Period, LFS will use the System to randomly generate one winning ticket number from among the numbers associated with purchased tickets. The Raffle will be conducted by a Draw Administrator and will be supervised by the Cash Cage Supervisor or a designate. An LFS representative may also be present. Any decisions by the Draw Administrator and/or LFS representative shall be final and binding. The winning Raffle Ticket number will be posted on LangleyEventsCentre.com/5050, and will be announced after the first break in game play in the third period to ensure that should the winner be present, that they claim the prize.





- 7. Prize Claim: Winners have 30 minutes after the end of regulation time to claim the prize at the Guest Services counter located on the third (3rd) floor concourse (at the Langley Events Centre). Alternately, the prize may be claimed within thirty (30) days of the applicable drawing by notifying Langley Facilities Society by email at 5050prizeclaim@tol.ca. If prize is claimed on event day, winner will be given \$500 cash with the remainder of the prize to be paid by cheque within 30 days. If the prize is claimed after the event but within 30 days, the full amount will be paid by cheque within 30 days of the claim date. Prize will only be awarded if the original ticket is presented in person and in physical form (photos and photocopies will not be paid out) Ticket must be in reasonable condition and in its original form. Illegible, soiled, cut up tickets will not be paid out. Unclaimed prizes may be added as a bonus to the prize of another draw within the next 12 months where similar ticket buyers are likely to be present. In the event that a Raffle Ticket is shared by multiple prize claimants, the direct purchaser of the Raffle Ticket will be awarded the prize and be responsible for distributing the winnings accordingly. LFS shall have no responsibility to any other person who claims any interest or right to receive all or any part of the prize associated with a winning ticket. The winner must sign a receipt form acknowledging the amount received and all information required by provincial gaming regulations to claim a prize. Any disputes/complaints shall be reported to the draw administrator or the person named on the gaming license.
- 8. Release of Liability: By entering into the Raffle, all entrants agree to be bound by these Official Rules and release LFS and any presenting partner of the 50/50 Raffle, and each of their respective partners, subsidiaries and affiliates, together with the owners, employees, officers, directors, sponsors and agents of any of the foregoing (collectively, "Released Parties") from and against any and all claims, demands, injuries, losses and liabilities whatsoever arising out of the Raffle.

  LFS will administer the Raffle in good faith and in the best interests of the charitable beneficiaries but shall not have any liability in connection with any decisions made in connection with the Raffle. Released Parties make no warranty, guaranty or representation of any kind concerning any prize (or any portion thereof); and disclaim any implied warranty. LFS's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Odds: The odds of winning the Raffle depend on the number of Raffle Tickets purchased for the drawing.

- 9. Governing Law: The Raffle and these Official Rules shall be subject to and governed by the laws of the Province of British Columbia. If a court of competent jurisdiction finds that any provision of these Official Rules, or their application to a particular person or circumstance, is invalid or unenforceable to any extent, then the remainder of these Official Rules shall remain enforceable to the fullest extent permitted by law. The venue for any cause of action arising out of the Raffle or these Official Rules shall be located in Vancouver, BC.
- 10. Publicity Release: Each winner, by accepting a prize, grants LFS and the Released Parties full permission, except where legally prohibited, to use such winner's name, address (city only), photograph, voice and/or other likeness, and prize information for advertising, trade and promotional purposes without further compensation and without notice, review or approval, in all media now known or hereafter discovered, worldwide and in perpetuity. Each winner shall execute all documents that LFS may require to be signed in connection with this release.
